

CASS COUNTY FAIR 2008 OPEN CLASS INFORMATION

SANITARY REGULATIONS

1. All animals on exhibit are subject to a daily examination by a licensed veterinarian.
2. Any animal showing signs of any contagious, infectious, or communicable disease shall be immediately removed from the grounds.

SUPERINTENDENTS

1. Superintendents will have full and complete charge of everything in their proper departments and will be looked to for proper arrangements and management, and also for the proper entertainment of the public in their respective departments.
2. Superintendents must be on the grounds to receive all articles belonging to their departments, and see that they are arranged in proper places for exhibition. Each superintendent is directed to familiarize him/herself with his/her duties in keeping proper records, handling of money passing through his/her hands, appointing of assistants, filing reports, and returning all books and records of their departments.
3. Superintendents may enter exhibits for display and/or competition in their own and other divisions.

REGULATIONS APPROVED BY CASS COUNTY FAIR BOARD AS FOLLOWS:

1. While the greatest possible care will be taken by the management to protect patrons of the Cass County Fair, each individual will be held personally responsible for his or her own actions. The management will not be responsible for any injury.
2. Distribution of promiscuous advertising matter is strictly prohibited. No tacking of advertising matter on buildings will be permitted. Exhibitors may distribute advertising matter from their places of exhibit only.
3. No person will be allowed to do any soliciting for any paper, merchandise, or articles unless they first obtain permission from the Secretary and pay the required fee.
4. All possible diligence or care will be exercised to prevent loss or injury to articles or animals on exhibit, but it is hereby expressly stipulated that the management of the Fair will in no way be responsible should any loss or injury occur.
5. All protests must be made in writing and accompanied by a deposit of \$5.00 which will be forfeited if protest is not sustained. Such protest must state plainly the cause of complaint or appeal, and must be filed with the Secretary by 12:00 noon of the last day of the Fair. Written protests must include: a) names of persons involved; b) description of the concern; c) situation and documentation; d) recommendation for correction; e) specific action rule, etc., in question; f) additional persons the committee may contact for clarification; and g) procedures and/or steps carried out by the person involved prior to submission to the Fair Board.
6. When a protest is to be made against the competition or an animal or article in any class, notice of the same must be filed with the Superintendent of the Department before the class is passed upon, that the judge may be instructed to place a reserve award that premiums may be properly distributed in the event of the protest being sustained.
7. No animal or article not listed in premium list will be entered for premium except as otherwise provided.
8. Articles that have won premiums in previous years will not be awarded premiums again.
9. The age of all animals shall be computed from the last day of the month in which they were born.
10. Any privilege or concession obtained under false representation will be revoked by the management, and any and all monies paid for the same will be forfeited to the society.
11. No monstrosities or beggars will be allowed on the grounds.
12. Campers will be parked at the north picnic area.
13. No premiums will be paid for poultry or rabbits if cages are not cleaned at the time they are released. Must be inspected by Superintendent to receive premiums.
14. No stalls in cattle barn will be cleaned during the auction.
15. It is illegal to use drugs not approved by USDA in meat animals.
